



## ENTRY CONDITIONS – TOURNAMENT RULES - COSTS

(01/06/2011 edition)

### I. ENTRY CONDITIONS

#### 1.1. Team registration

1.1.1. The tournament is especially organised for football teams made up of lawyers from one bar or an association of lawyers from a maximum of four bars.

1.1.2. National selections are not allowed. The concept of a team composed of a nation's best players is ruled out.

1.1.3. Each squad must comprise a minimum of 13 players and a maximum of 25 players.

#### 1.2. Qualification of the players

1.2.1 All teams taking part in the competition must take the following into account:

(a) Except the special cases mentioned hereinafter in paragraph 1.2.1 (b), the players must all be:

- Lawyers regularly registered with the bar, where the notion of the Bar Association exists in the country concerned;
- Legal counsels or similar when the notion of the Bar Association does not exist in the country concerned.

(b) Exemptions:

- No exemption request for a non-lawyer **currently playing or having been playing in a football club at any level**, can be accepted;

- **Only one player aged over 30** on the date of the start of the Mundiavocat (1<sup>st</sup> June 2012), and **belonging to the legal or judicial family** (trainee lawyers, bailiffs, lawyers responsible for procedure and judicial experts) may be authorised. To be admissible, the exemption request must be sent by post or email by the team captain to Vincent Pinatel before 1<sup>st</sup> of April 2012.

(c) These conditions are imperative but are not sufficient to guarantee an exemption.

1.2.2. Any team found guilty of fielding a player who does not meet the entry criteria mentioned in paragraph 1.2.1 will forfeit the match. The win and the three points will be awarded to the opposing team who will receive a 3-0 result or more depending on the result of the match.

***\*Special entry conditions for the MUNDIAVOCAT MASTER tournament:***

- *The players must be aged over 35 years old.*
- *5 exemptions may be granted for lawyers aged between 30 and 35 years old*
- *1 exemption may be granted for a non-lawyer aged over 35 years old*
- *a player having been replaced may enter again in the same game*

*NB: even if your team meets the entry conditions for the MUNDIAVOCAT MASTER, be aware that you can choose to participate in one or other of the two tournaments.*

#### 1.3. How to enter

1.3.1. To enter and be given a licence, which is obligatory for a player to appear on the match sheets, each player must provide the following documents:

(a) A professional certificate:

- For lawyers: a photocopy of their lawyer's card as well as an individual certificate to prove they belong to the profession. This certificate has to be signed by the President of the Bar Association.

- For non-lawyers benefitting from an exemption: an individual certificate of belonging to the profession explaining their activity in addition to a sworn statement signed by the team captain certifying that the player requesting an exemption has never been played in a football club at any level.

(b) A medical certificate less than three months old authorising the practice of competitive football in the conditions of the Mundiavocat (7 60-minute football matches in 8 days);



- (c) A photocopy of their passport
- (d) A photo ID
- (e) An individual form completed and signed by each player

1.3.2. The licences will be issued for each team at the start of the tournament. No additional players could be added, and therefore have a licence issued during the competition.

1.3.3. To get their accreditation mentioning their licence number, all the players must present, in person, before the start of the tournament, original copies of the professional certificates provided (professional cards for lawyers, certificates of belonging to the profession for those exempt). This condition is compulsory to get the accreditations enabling to take part in the competition.

1.3.4. No accreditation will be given to teams who haven't fully paid their fees and presented all the required documents.

## II. EXTRACT FROM THE TOURNAMENT RULES

### 2.1. Competition format

2.1.1. The competition will take place in two phases: a preliminary phase and a ranking phase.

2.1.2. The teams taking part in the competition will be split into groups of three or four teams. The number of groups will be determined according to the total number of participating teams.

2.1.3. Each match will last 60 minutes: two halves of 30 minutes with a 10-minute break.

2.1.4. In the ranking phases, if the score is tied after the allocated time, the winner will be decided by penalties (a series of five).

2.1.5. In the ranking phases, if the score is still tied after the penalty shoot out, the "sudden death" principle will apply: both teams will shoot a penalty in turns. The first to lead after an equivalent number of shots, wins the match.

2.1.6. Prior to the tournament and upon arrival or just before the draw at the latest, each captain will be provided with the complete rules of the competition.

### 2.2. Trophies

2.2.1. The winning team, the runner-up and the team ranked third in each tournament will receive a trophy as well as medals (gold, silver and bronze) for every player.

2.2.2. All the other teams from both tournaments will each receive a participating cup according to its results.

2.2.3. Trophies will also be awarded for the following distinctions in each of the two tournaments, CLASSIC and MASTER: best goal scorer, best player, best goalkeeper, best manager and top fair-play team.

## III. ENTRY

The entry fees for the 16<sup>th</sup> edition of the MUNDIAVOCAT CLASSIC or the 3<sup>rd</sup> edition of the MUNDIAVOCAT MASTER are composed of:

- registration fees per team
- accommodation costs per person

### 3.1. Registration fees per team

These registration fees is set per team and costs €7,000.

**These fees include:** all expenses relating to the organisation of the tournament, the availability of football pitches, the balls, the refereeing (3 officials per match), water on the pitches, medical assistance on each field, the trophies and the medals.





### 3.2. Accommodation costs per person

Various accommodation options are proposed in paragraph IV "Accommodation package prices".

### 3.3. How to enter

If you are interested to take part in this competition, send us all of the documents required for your entry by post, mail or fax.

The entry period opens upon reception of this document and closes 3 weeks prior to the start of the tournament.

## IV. ACCOMMODATION PACKAGE PRICES

### 4.1. Accommodation costs per person in the VILLA RUBIN, AMARIN and VALDALISO apart-hotels\* based on 2-people sharing on a B&B basis

- Category I, "aparthotel": €580 \*\*
- Category II, "aparthotel": €490

\* an "aparthotel" comprises a studio with a kitchenette and is inside a resort with restaurants and supermarkets.

\*\*some category I apartments may be occupied by 3 or 4 people. In this case, the first 2 people pay 580€ and the 3<sup>rd</sup> or potentially the 4<sup>th</sup> person pays 550€.

### 4.2. Accommodation costs per person in a hotel room based on 2 people sharing on a B&B basis

- Category A, ISTRAN and EDEN hotels: €920
- Category B, PARK and KATARINA hotels (located on an island facing Rovinj harbor): €760
- Category C, VALDALISO hotel: €610

#### **These rates include:**

- accommodation in a double/twin room for 9 nights from 1<sup>st</sup> to 10<sup>th</sup> June 2012
- local tax,
- breakfast,
- a welcome cocktail,
- the gala and awards ceremony,
- repatriation assistance insurance,
- the application fees.

**These rates don't include:** meals, return transportation from your home to Rovinj, personal expenses (telephone, minibar and laundry), return airport/hotel transfers and hotel/football pitch transfers, accommodation cancellation insurance and excursions.

#### **Warning:**

- We only have a limited number of rooms available in each category. We advise you to book your accommodation early so as to get the category and rate of your choice.
- For latecomers, the allocation will be made in accordance with the rooms which are left.

## V. PAYMENT OF TOURNAMENT ENTRY AND ACCOMMODATION FEES

So that your participation can be officially confirmed, you must respect to the following payment schedule:

- Before the **15th September 2011: € 3,000** (deposit for the registration fees and 20% of the team's accommodation fees)
- Before the **15th January 2012: € 5,000** (balance of the registration fees and 30% of the team's accommodation fees)
- Before the **30th April 2012: Balance** (the remaining 50% of the team's accommodation fees)

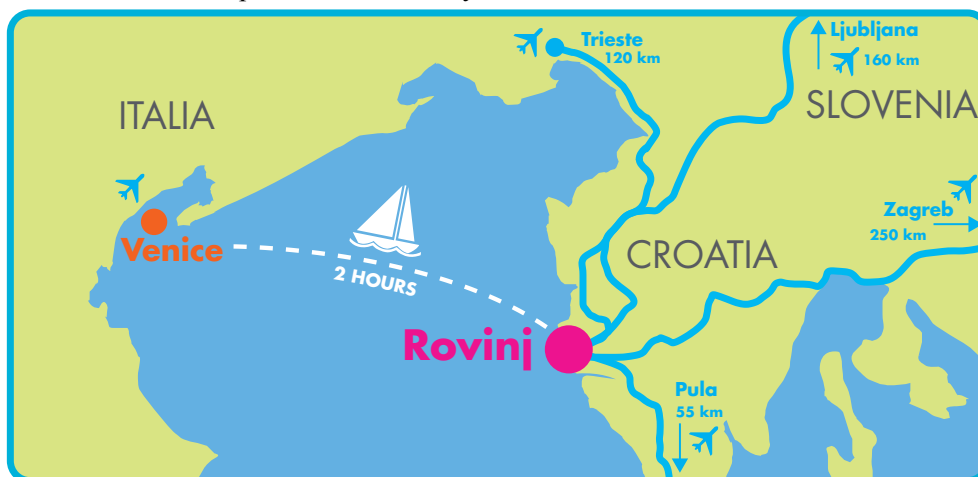
